- November 1-3: 7:30 a.m. 7:30 p.m.
- November 4: 8:00 a.m. 4:00 p.m.
- November 5: 1:00 p.m. 5:00 p.m.

# **Government Shutdown Updates**

Work on appropriations bills will resume now that the House of Representatives narrowly elected Rep. Mike Johnson, R-La., to be the new speaker.

The FY24 agriculture appropriations bill is to be considered the week of Nov. 13, the same week government funding runs out under the current continuing resolution.

If the House cannot pass all 12 of the FY24 appropriations bills before the Nov. 17 government funding deadline, Speaker Johnson will push for a shortterm continuing resolution to fund the government through Jan. 15 or April 15.

As a reminder, if Congress does not pass legislation to fund the federal government—either full-year appropriations legislation or another continuing resolution -by Nov. 17, the government will shut down on Nov. 18

Additionally, the House is working toward passing a 2023 Farm Bill as soon as December.

We will continue to monitor our advocacy resources and provide updates on progress towards passing a federal budget and Farm bill. Stay tuned!
