The Mid-Ohio Food Collective (MOFC) works to connect our hungry neighbors with nutritious food, stabilizing families today while helping them access resources for tomorrow. We collaborate with a network of roughly 680 agency partners, which include food pantries, soup kitchens, shelters, after-school programs, and senior sites, to provide food to over 560,000 individuals across 20 central and eastern Ohio counties. In the past year, MOFC distributed over 76 million pounds of food and groceries; more than half consisted of fresh foods such as fruits, vegetables, dairy, meat, and bread. In total, these efforts allowed us to provide enough food for more than 175,000 meals each day. For every \$1 donated to MOFC, the organization is able to leverage \$4.89 in groceries, and provide enough food for 2.4 meals.

FY22 ended with a deficit of \$3.7M versus a surplus of \$27.0M in FY21 (including Campaign of \$25.2M). FY22 experienced a \$35.5M decrease in revenue, partially offset by a \$4.8M reduction in expenses.

Cash, Investments and Receivables of \$44.3M are available to meet \$38.5M of obligations. Those being \$25.2M Donor Restrictions, \$10.5M Operating Reserve, \$2.3M Capital Fund and \$0.5M Board Designated.

FY22 continued to experience an increased need. We distributed 77 million pounds and served over 564,000 food insecure individuals.

We expect to continue to experience an increased need; due to rising costs from inflation, reduced assistance programs and a possible recession.
